I agree to pay the applicable temporary houseguest membership fee. I further understand that as the sponsoring member I remain responsible for all unpaid charges made by my Houseguest. I shall be responsible for the conduct of my Houseguest while at the Club. If the manner, deportment or appearance of my Houseguest is deemed to be unsatisfactory, I shall, at the request of the Club, cause such Houseguest to surrender the guest card and leave the premises of the Club.

HOUSEGUEST SECTION TO COMPLETE

Houseguest agrees to release and indemnify the Company, any manager of the Club Facilities, their affiliates, their successors and assigns and their respective shareholders, partners, directors, officers, members, employees, representatives, agents and members of the Club's advisory board or committees in accordance with the provisions of the Customs and Courtesies of the Club.

Houseguest understands that his or her right to utilize the Club Facilities and enjoy the privileges of the Club is derived from being a houseguest of the sponsoring Club member and that Houseguest holds no independent rights or privileges to utilize the Club Facilities or to enjoy any of the privileges of the Club, other than pursuant to such membership. Houseguest acknowledges that houseguest privileges are subject to the Club's Customs and Courtesies. If the manner, deportment or appearance of Houseguest or his or her family is deemed to be unsatisfactory, Houseguest shall surrender the guest card and leave the premises of the Club at the request of the sponsoring member or Club staff.
